**WAIVER AND RELEASE OF LIABILITY**

**MINOR AMATEUR ATHLETIC WAIVER & RELEASE OF LIABILITY (UNDER 18 YEARS OF AGE)**

**In consideration of being allowed to participate in any way in the College Bound Basketball Club, the Columbus Knights Basketball Club, the Capital City Comets AAU Girls Basketball Club, College Bound Soccer Club, College Bound Summer League, College Bound Athletic Connection and related events and activities, the undersigned:**

1. Acknowledge, and represent that I, the minor's parent and /or legal guardian, understand the nature of Athletic Activity and the minor's experience and capabilities and believe the minor to be qualified, in good health, and in proper physical condition to participate in such activity. I further agree that the parent(s) or legal guardian(s) will instruct the minor participant that prior to participating, he or she should inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he or she should immediately advise his or her coach or supervisor of such condition(s) and refuse to participate.
2. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence, but the actions, inactions, or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known or not reasonably foreseeable at this time.
3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.

Release, waive, discharge and covenant not to sue the Christian Sport Camps, Inc., Columbus Knights Basketball Club, College Bound Soccer Club, Capital City Comet's AAU Girls Basketball Club, College Bound Summer League, College Bound Athletic Connection, the affiliates of Christian Sport Camps and its affiliated clubs, their respective administrators, directors, agents, coaches, and other employees and volunteers of the organization, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessees of premises used to conduct the event, all of which are hereinafter referred to as "releasee," from any and all liability to each of the undersigned, his or her heirs and next of kin for any claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.

I/WE, THE UNDERSIGNED, HAVE READ THE ABOVE WAIVER & RELEASE, UNDERSTAND THAT I/WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT VOLUNTARILY WITHOUT INDUCEMENT AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY.
